## From Century City Office:

- Exit the building onto Avenue of the Stars, turn right, proceed past the first traffic signal, and turn left onto Santa Monica Blvd.
- Proceed on Santa Monica Blvd. for 1.9 mi.
- Turn left onto the San Diego Freeway (I-405) south.
- Proceed south on the San Diego Freeway (I-405) for 44.1 mi.
- Transition to the Corona Del Mar Freeway (73) south; continue on transition road for 0.5 miles.
- Continue south on the Corona Del Mar Freeway (73) for 2.3 mi.
- Exit at Jamboree Rd. and turn right; continue on Jamboree Rd. for 2.3 mi.
- Turn left onto Santa Barbara Dr. and proceed for 0.5 mi.
- Turn left onto Newport Center Dr. and proceed for 0.1 mi.
- Turn left onto Santa Maria Rd. and proceed for 0.1 mi.
- Turn in to the first driveway on the left.

#### From LAX:

- Turn right on Sepulveda Blvd. and proceed for 0.9 mi.
- Take the Century Freeway (I-105) east for 1.6 mi.
- Transition to the San Diego Freeway (I-405) south; continue on transition road for 1.5 mi.
- Continue south on the San Diego Freeway (I-405) for 33.5 mi.
- Transition to the Corona Del Mar Freeway (73) south; continue on transition road for 0.5 miles.

- Continue south on the Corona Del Mar Freeway (73) for 2.3 mi.
- Exit at Jamboree Rd. and turn right; continue on Jamboree Rd. for 2.3 mi.
- Turn left onto Santa Barbara Dr. and proceed for 0.5 mi.
- Turn left onto Newport Center Dr. and proceed for 0.1 mi.
- Turn left onto Santa Maria Rd. and proceed for 0.1 mi.
- Turn in to the first driveway on the left.

### From John Wayne Airport:

- Exit the airport onto MacArthur Blvd. and turn right.
- Proceed on MacArthur Blvd. for 1.4 mi.
- Turn right onto Jamboree Rd. and proceed for 2.7 mi.
- Turn left onto Santa Barbara Dr. and proceed for 0.5 mi.
- Turn left onto Newport Center Dr. and proceed for 0.1 mi.
- Turn left onto Santa Maria Rd. and proceed for 0.1 mi.
- Turn in to the first driveway on the left.
